The NORDDiffuser air distribution devices are designed to be stylishly unnoticeable, blending in smoothly with the surrounding environment. The air diffusers are made of standard hot-dip galvanized sheet steel and painted white with powder paint (RAL 9003). The air diffusers can also be manufactured of special materials and coated with the colour indicated by the customer.

## MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory. The manufacturing site is equipped with an onsite rooftop photovoltaic system.

The manufacturing process begins with cutting, where raw materials are cut to the required dimensions using mechanical cutting methods.

After cutting, the components proceed to the bending stage. During this phase, the parts are bent and formed to achieve the required shapes and geometries according to product specifications.

Following bending, the components are sent to the painting stage. Surface treatment and coating are applied to provide the required finish and corrosion protection.

Once painting is completed, the components move to the assembly stage. Individual parts are assembled, and all functional elements are installed to form the finished product.

After assembly, the products undergo testing to verify functionality, dimensional accuracy, and compliance with applicable requirements.

In the final stage, the tested products are packaged. Each unit is placed into protective packaging and prepared for transport, after which the products are palletized and made ready for shipment.

For packaging products, we use corrugated cardboard boxes made from multi-layer board. The boxes are mechanically cut, folded and glued by the packaging supplier and delivered to us in flat form. During our packaging process, the boxes are opened, filled with the required number of regulating dampers, and then closed and placed onto pallets for transport.

## TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The product is sold globally, however, the primary target market is Finland, and therefore the transport scenario has been defined accordingly. The average transportation distance from the production plant to the final client in Helsinki, Finland is 130 km (80 km by ferry, 50 km by lorry). The transportation method is assumed to be a lorry 16-32t, which is the most common way of transport in the region. According to the manufacturer, transportation doesn't cause losses as products are packaged properly. Vehicle capacity utilization volume factor is assumed to be 1.

The impacts of product installation have not been assessed, as the quantities of fixing materials used vary depending on the building structure, and site-specific conditions.

Packaging waste treatment has been included. It is assumed that the wooden pallet is incinerated (Nordic council of Ministers, 2022). Plastic packaging is assumed to be incinerated with energy recovery (Eurostat, 2020). Waste paperboard is assumed to be recycled, as the most common treatment option for paper waste in Finland, where approximately 54% of paper waste is recycled (Eurostat, 2024).

## PRODUCT USE AND MAINTENANCE (B1-B7)

This EPD does not cover the use phase.

Air, soil, and water impacts during the use phase have not been studied.

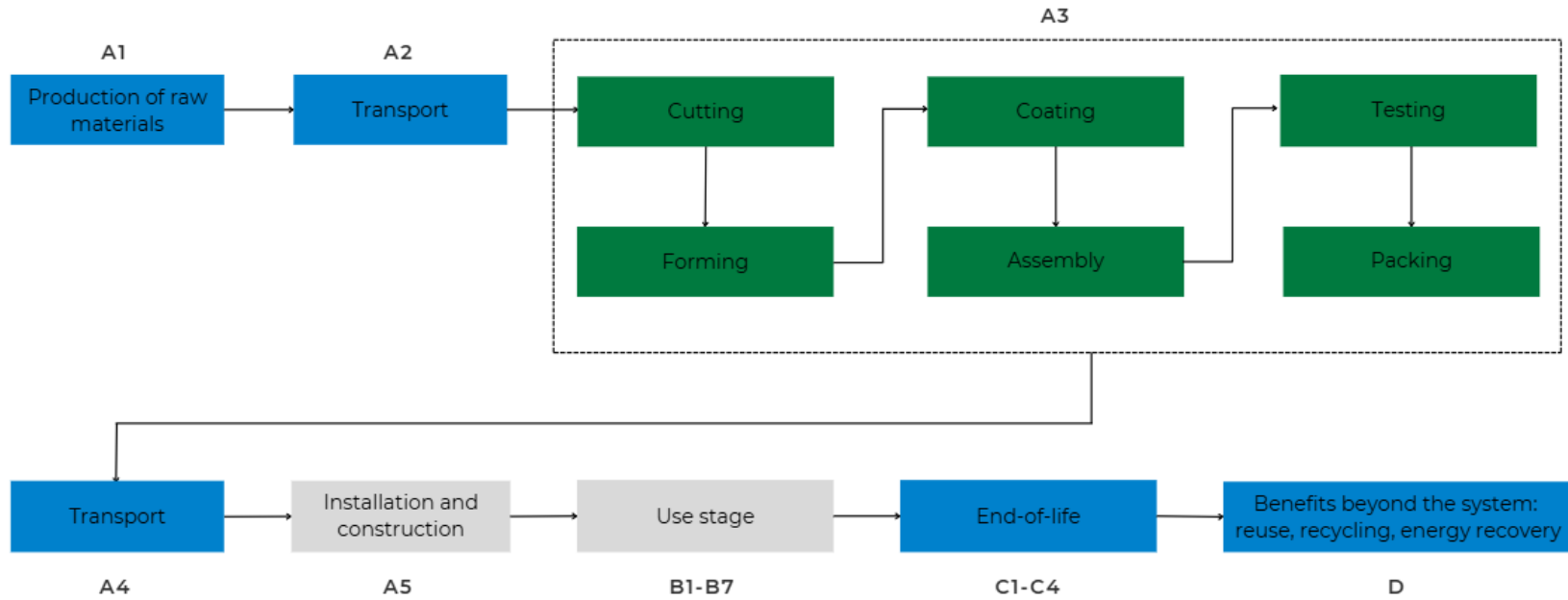
## PRODUCT END OF LIFE (C1-C4, D)

The demolition is assumed to require 1.1 kWh of energy per tonne of product. It is assumed that 100% of the product is collected and transported

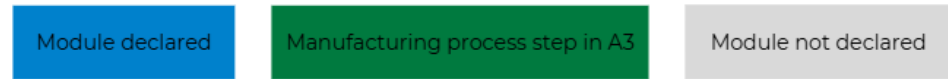
50 km to closest treatment facility. 90% of metal is sent to recycling and 10% of metal is assumed to be landfilled (EuRIC, 2019).

Any material that left the product system in C3 has been considered in module D. Only net flows are considered. Waste packaging from A5 has also been considered. Module D scenario is representative of Europe.

## LIFE-CYCLE ASSESSMENT

### CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

### VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

### ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:
