PRODUCT DESCRIPTION

NORDroof roof hoods are rectangular or round air intake devices and exhaust air diffusers.

Standard connection methods are possible for both round and rectangular duct fittings or, alternatively, with a flashing fitting. We recommend using the flashing fitting with all our roof hoods. Standard factory-made fittings ensure good rain resistance and are easy and quick to install. The advantages of the respective products are weather resistance, durable construction and low-pressure loss.

NORDroof products are suitable for different objects and can withstand different weather conditions. They are used in industrial, commercial and residential buildings, as well as at airports, stadiums, etc.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory. The manufacturing site is equipped with an onsite rooftop photovoltaic system.

The manufacturing process begins with cutting, where sheet metal components are precisely cut to the required dimensions from flat sheet material using mechanical cutting methods. After cutting, the parts proceed to the bending stage. During this phase, the components are bent and formed to achieve the required shapes and geometries according to product specifications. Once bending is completed, the components move to the assembly stage. Here, individual parts are joined together, and all functional elements are installed to form a complete product. The assembled units are checked to ensure proper fit and functionality. In the final stage, the finished products are packaged. Each unit is placed into protective corrugated cardboard packaging and prepared for transport. The packaged products are then stacked on pallets and made ready for shipment to customers.

The roof hoods are packed in corrugated cardboard and plastic film and placed on a wooden pallet. The package is then secured to the pallet with plastic straps.

Waste steel from manufacturing is separately collected and sent for recycling. Powder coating residues are transferred to authorised waste treatment.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The product is sold globally, however, the primary target market is Finland, and therefore the transport scenario has been defined accordingly. The average transportation distance from the production plant to the final client in Helsinki, Finland is 130 km (80 km by ferry, 50 km by lorry). The transportation method is assumed to be a lorry 16-32t, which is the most common way of transport in the region. According to the manufacturer, transportation doesn't cause losses as products are packaged properly. Vehicle capacity utilization volume factor is assumed to be 1.

The impacts of product installation have not been assessed, as the quantities and types of fixing materials used vary depending on the installer, building structure, and site-specific conditions.

Packaging waste treatment has been included. It is assumed that the wooden pallet is incinerated (Nordic council of Ministers, 2022). Plastic packaging is assumed to be incinerated with energy recovery (Eurostat, 2020).

This EPD does not cover the use phase.

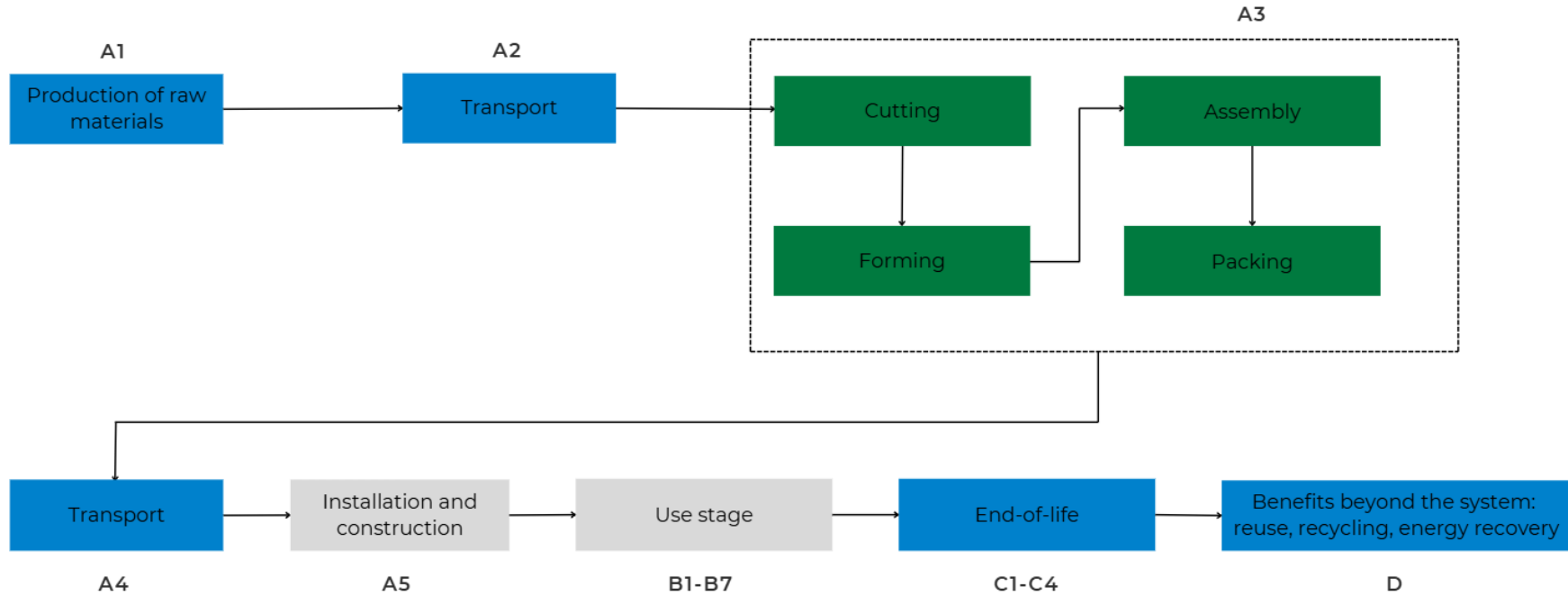

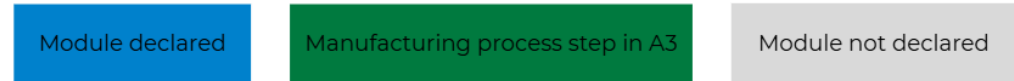
The demolition is assumed to require 1.1 kWh of energy per tonne of product. It is assumed that 100% of the product is collected and transported 50 km to closest treatment facility. 90% of metal is sent to recycling and 10% of metal is assumed to be landfilled (EuRIC, 2019).

Any material that left the product system in C3 has been considered in module D. Only net flows are considered. Waste packaging from A5 has also been considered. Module D scenario is representative of Europe.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

This EPD covers a group of products within the NORDrroof product group. Products are grouped based on similar functionality and similarity in composition, with consistent manufacturing processes. A single representative product, UVE, was selected for the LCA modeling based on market share. The variation in fossil GWP (A1–A3) across the group is ± 15%, ensuring the declared impacts are representative of all products covered.

Minimal impacts were calculated for flange VRL (-15%) and maximum impacts were calculated for the representative product UVE. GWP-fossil varies mainly due to the differences in material composition and use of fossil-based materials.

The environmental product declaration covers the following roof hoods:

- air intake louvres ULS, URS, ULK
- exhaust air cooler ULV2, ULV2P, UVE, UVK2, UVS
- combined intake/exhaust terminal UHC
- weather hood NTH
- round saddle with flashing MKLV
- round duct connector with connection profile MKLU
- flange VRL
- flashing collar MKLF

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator for EPD Hub V3 and EPD Process Certification v3.2.3. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1/3.11 and One Click LCA databases as sources of environmental data.
